Assumption of the Risk and Waiver of Liability Relating to Corona virus/Covid-19

The coronavirus, Covid-19, has been declared a worldwide pandemic by the World Health Organization. Covid- 19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Studio J School of Dance LLC ("SJ") has put in place preventative measures to reduce the spread of Covid-19, however, SJ cannot guarantee that you or your child(ren) will not become infected with Covid-19. Further, attending SJ could increase your risk and your child(ren)'s risk of contracting Covid-19.

By signing this agreement, I acknowledge the contagious nature of Covid-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by Covid-19 by attending SJ and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand

that the risk of becoming exposed to or infected by Covid-19 at SJ may result from the actions, omissions, or negligence of myself and others, including, but not limited to SJ employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at SJ or participation in SJ programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of a relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence SJ, its employees, agents, and representatives, whether a Covid-19 infection occurs before, during, or after participation in any SJ program.

Performer and Guardian agree to abide by the following guidelines:

1. Performers will NOT come to practice if they have a temperature or do not feel well in any way. Performers will be fever free for 48 hours with no medication prior to returning to the studio.
2. Each performer will be required to bring their own water bottle to drink. Water fountain is closed.
3. Guardians agree to discuss social distancing with your performer prior to every practice, private lesson or class.
4. Correct hand washing or hand sanitizing will be done before and after each practice, private lesson or class.
5. Performers will not arrive more than 5 minutes prior to practice starting.
6. Parents will pick up promptly on time.
7. Proper social distancing practices will be adhered to at home.
8. If you feel like your child should wear PPE they need to provide their own.
